

Case-Level Investigations

(FIU Standard Workflow)

When alerts escalate, investigators need context fast. GraphyteSearch generates a digital dossier combining sanctions, PEPs, adverse media, registries, and network relationships. Risk-relevant details are highlighted, identities resolved, and audit-ready reports produced quickly. While internal data analysis remains critical, Quantifind reduces the time spent gathering external context.



Automated Case Enrichment

(Pipeline Integration)



Case Triage and Prioritization

(Upstream Risk Scoring)

Not all alerts deserve equal attention. Quantifind enriches customers and counterparties upstream and feeds intelligence into triage or risk models. Low-risk alerts can be auto-closed, while high-risk typologies such as fentanyl trafficking route to specialized teams, sharpening focus on the cases that matter most.
